Additionally, successful candidates thrive in an environment with a dynamic team that is highly mission driven. The position reports to the Senior Director of Programs and Operations.

You will work on:

- **Leading the EC Freight Electrification Program:** Lead a team in developing and implementing an effort to electrify freight across the U.S., including collaborating with the development team to create a fundraising strategy; develop and support pilot programs, policy analysis and advocacy, market development strategies, technical assistance, and public/private sector partnerships.
- **Corporate Engagement:** Including ongoing engagement with the significant network of partners the EC has already established and continuing to build upon this to strengthen our freight work.
- **Thought Leadership and Organization Representation:** Contribute to technical documents and white papers, attend external events as a representative of the EC and our Freight Electrification program, raising awareness of the EC's work, and build relationships with relevant parties.
- **Work inter-departmentally:** Support the development and communications divisions to provide support as required.

The Program Manager Freight Electrification will help develop the first Freight Electrification program in the United States. The position will also create a city-specific roadmap and the programmatic conditions needed to expand community-level adoption of EVs. As corporations call on the EC to advance the electrification of their fleets and support critical EV policies and programs, the Program Manager will engage with key constituencies and decision-makers to create these pathways. Engagement could include developing policies and programs that support infrastructure planning and implementation, fleet purchasing requirements, utility rate review, building, and zoning codes, or other legislative measures.

This position represents the EC and our preferred policies and programs to leaders and members of communities such as state agencies, municipalities, a diversity of NGOs, the media, and the general public.
